SWEEPSTAKES OFFICIAL RULES:

No purchase necessary to enter or win.

VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be at least (eighteen) 18 years of age or older (or the age of majority in your state whichever is older), a legal resident of, and reside within, the 50 United States and the District of Columbia ("U.S.") at the time of entry to participate in this Sweepstakes ("Entrant").

1. SWEEPSTAKES TIMING:

The Medora Vacation Giveaway (the "**Sweepstakes**") begins on 5/10/23 at 12:00:00 a.m. Mountain Daylight Time ("**MDT**") and ends on 6/30/23 at 11:59:59 p.m. MDT (the "**Sweepstakes Period**"). At the end of the Sweepstakes Period, a random drawing will be conducted from among all eligible entries received to select one (1) prize winner (a "**Winner**") on or about 7/3/23 ("**Drawing Date**").

2. ELIGIBILITY:

Employees, officers, and directors of the Theodore Roosevelt Medora Foundation (the "**Sponsors**") and Lawrence & Schiller (the "Administrator"), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), immediate family members (as defined by the IRS including spouse, parents, grandparents, siblings, children and grandchildren) and/or people living in the same household (whether or not related) and all other companies associated with the Sponsors and Administrator (collectively, the "**Sweepstakes Entities**") are not eligible to participate in the sweepstakes. The Winner will not receive the difference between the actual and approximate retail value of the prize. Sponsors will not replace any lost, mutilated, or stolen prize. 10. GOVERNING LAW/JURISDICTION:
