

SWEEPSTAKES OFFICIAL RULES:

No purchase necessary to enter or win.

VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be at least (eighteen) 18 years of age or older (or the age of majority in your state whichever is older), a legal resident of, and reside within, the 50 United States and the District of Columbia ("U.S.") at the time of entry to participate in this Sweepstakes ("Entrant").

1. SWEEPSTAKES TIMING:

The Medora Vacation Giveaway (the "**Sweepstakes**") begins on 5/10/23 at 12:00:00 a.m. Mountain Daylight Time ("**MDT**")] and ends on 6/30/23 at 11:59:59 p.m. MDT (the "**Sweepstakes Period**"). At the end of the Sweepstakes Period, a random drawing will be conducted from among all eligible entries received to select one (1) prize winner (a "**Winner**") on or about 7/3/23 ("**Drawing Date**").

2. ELIGIBILITY:
