OFFICIAL RULES:

No purchase necessary to enter or win.

VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be at least (eighteen) 18 years of age or older (or the age of majority in your state whichever is older), a legal resident of, and reside within, the 50 United States and the District of Columbia (“U.S.”) at the time of entry to participate in this Sweepstakes (“Entrant”).

1. SWEEPSTAKES TIMING:

The Medora Vacation Giveaway (the “Sweepstakes”) begins on 7/15/23 at 12:00:00 p.m. Mountain Daylight Time and ends on 9/11/23 at 12:00:00 a.m. Mountain Daylight Time (the “Sweepstakes Period”). At the end of the Sweepstakes Period, a random drawing will be conducted from among all eligible entries received to select one (1) prize winner (a “Winner”) on or about 9/12/23 (“Drawing Date”).

2. ELIGIBILITY:

Employees, officers, and directors of The Theodore Roosevelt Medora Foundation (the “Sponsors”) and Lawrence & Schiller (the “Administrator”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), immediate family members (as defined by the IRS including spouse, parents, grandparents, siblings, children and grandchildren) and/or people living in the same household (whether or not related) and all other companies associated with the Sponsors and Administrator (collectively, the “Sweepstakes Entities”) are not eligible to participate in the sweepstakes. USE OF DATA: Sponsors and Administrator will be collecting personal data about the Entrants online, in accordance with Sponsors' privacy policies. Please review [Sponsors' privacy policies](#). By participating in the sweepstakes, Entrants hereby agree to the collection and usage of their personal information and acknowledge that they have read and accepted Sponsors' privacy policies.

The Winner will not receive the difference between the actual and approximate retail value of the prize. Sponsors will not replace any lost, mutilated, or stolen prize. No transfers or substitutions will be made except as provided herein, in the Sponsors' sole discretion. The prize, including any portions thereof, is not redeemable for cash. No cash alternative or substitution will be allowed, except Sponsors reserve the right in their sole discretion to substitute a particular prize for one of comparable or greater value if any prize is unavailable, in whole or in part, for any reason.

10. GOVERNING LAW/JURISDICTION:
