2024 BULLY PULPIT GUEST SATISFACTION SURVEY VACATION GIVEAWAY

OFFICIAL RULES:

No purchase necessary to enter or win.

VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be at least (eighteen) 18 years of age or older (or the age of majority in your state whichever is older), a legal resident of, and reside within, the 50 United States and the District of Columbia (“U.S.”) at the time of entry to participate in this Sweepstakes (“Entrant”).

1. SWEEPSTAKES TIMING:

The 2024 Bully Pulpit Vacation Giveaway (the “Sweepstakes”) begins on 6/5/24 at 12:00:00 p.m. Mountain Daylight Time and ends on 9/11/24 at 12:00:00 a.m. Mountain Daylight Time (the “Sweepstakes Period”). At the end of the Sweepstakes Period, a random drawing will be conducted from among all eligible entries received to select one (1) prize winner (a “Winner”) on or about 9/12/24 (“Drawing Date”).

2. ELIGIBILITY:

Employees, officers, and directors of The Theodore Roosevelt Medora Foundation (the “Sponsors”) and Lawrence & Schiller (the “Administrator”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), immediate family members (as defined by the IRS including spouse, parents, grandparents, siblings, children and grandchildren) and/or people living in the same household (whether or not related) and all other companies associated with the Sponsors and Administrator (collectively, the “Sweepstakes Entities”) are not eligible to participate in the sweepstakes. B. Complete your entry by agreeing to the Official Rules and submit your entry. Once you submit your entry you will receive one (1) entry into the Sweepstakes.

LIMIT: One (1) entry per person over the Sweepstakes Period.

USE OF DATA: Sponsors and Administrator will be collecting personal data about the Entrants online, in accordance with Sponsors' privacy policies. Please review [Sponsors' privacy policies](#). By participating in the sweepstakes, Entrants hereby agree to the collection and usage of their personal information and acknowledge that they have read and accepted Sponsors' privacy policies.

Entries made by any other individual or any entity, including but not limited to commercial sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified for this Sweepstakes. If, despite reasonable efforts, any potential prize Winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize notification is returned as unclaimed or undeliverable to such potential prize Winner, such potential prize Winner will forfeit his or her prize and an alternate Winner will be selected in a second random drawing from all eligible entries received. B. 10. GOVERNING LAW/JURISDICTION:
