2024 MEDORA GUEST SATISFACTION SURVEY VACATION GIVEAWAY

OFFICIAL RULES:

No purchase necessary to enter or win.

VOID WHERE PROHIBITED BY LAW OR REGULATION. You must be at least (eighteen) 18 years of age or older (or the age of majority in your state whichever is older), a legal resident of, and reside within, the 50 United States and the District of Columbia (“U.S.”) at the time of entry to participate in this Sweepstakes (“Entrant”).

1. SWEEPSTAKES TIMING:

The 2024 Medora Vacation Giveaway (the “Sweepstakes”) begins on 6/5/24 at 12:00:00 p.m. Mountain Daylight Time and ends on 9/11/24 at 12:00:00 a.m. Mountain Daylight Time (the “Sweepstakes Period”). At the end of the Sweepstakes Period, a random drawing will be conducted from among all eligible entries received to select one (1) prize winner (a “Winner”) on or about 9/12/24 (“Drawing Date”).

2. ELIGIBILITY:

Employees, officers, and directors of The Theodore Roosevelt Medora Foundation (the “Sponsors”) and Lawrence & Schiller (the “Administrator”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), immediate family members (as defined by the IRS including spouse, parents, grandparents, siblings, children and grandchildren) and/or people living in the same household (whether or not related) and all other companies associated with the Sponsors and Administrator (collectively, the “Sweepstakes Entities”) are not eligible to participate in the sweepstakes. LIMIT: One (1) entry per person over the Sweepstakes Period.

USE OF DATA: Sponsors and Administrator will be collecting personal data about the Entrants online, in accordance with Sponsors' privacy policies. Please review [Sponsors' privacy policies](#). By participating in the sweepstakes, Entrants hereby agree to the collection and usage of their personal information and acknowledge that they have read and accepted Sponsors' privacy policies.

NOTE: Entry must be made by the Entrant only. Entries made by any other individual or any entity, including but not limited to commercial sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes is prohibited and any entries deemed by Administrator, in its sole discretion, to have been submitted in this manner will be void. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Administrator's satisfaction, the affected entry will be deemed ineligible.

The Winner will not receive the difference between the actual and approximate retail value of the prize. Sponsors will not replace any lost, mutilated, or stolen prize. No transfers or substitutions will be made except as provided herein, in the Sponsors' sole discretion. The prize, including any portions thereof, is not redeemable for cash. No cash alternative or substitution will be allowed, except Sponsors reserve the right in their sole discretion to substitute a particular prize for one of comparable or greater value if any prize is unavailable, in whole or in part, for any reason.

Winner will be required to provide proof of identity, verification of eligibility and compliance with these Official Rules, and, unless prohibited by law, a complete written Affidavit of Eligibility/Release of Liability Form, W-9 tax payer request for identification form and where legal, Publicity Release ("Affidavits"), all of which must be received fully-executed within five (5) business days of receipt or such potential prize winner may be disqualified and the alternate Winner will be offered the Prize.

Potential prize Winner will be notified within five (5) days of the drawing date by email by the Administrator, using the contact information provided at the time of entry. Sponsors shall have no liability for any potential prize Winner notification that is lost, intercepted or not received by any potential prize Winner for any reason. If, despite reasonable efforts, any potential prize Winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize notification is returned as unclaimed or undeliverable to such potential prize Winner, such potential prize Winner will forfeit his or her prize and an alternate Winner will be selected in a second random drawing from all eligible entries received. If any potential prize Winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential prize Winner will be disqualified, and an alternate Winner will be selected.

B. Administrator, in its sole discretion, reserves the right to disqualify any individual it finds to be tampering with the entry process or the operation of this Sweepstakes, gains unauthorized access to accounts, or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner and void all associated entries. 10. GOVERNING LAW/JURISDICTION:

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant, Administrator and Sponsors in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of North Dakota, without giving effect to any choice of law or conflict of law rules (whether of the State of North Dakota or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of North Dakota. Any lawsuit pertaining to or affecting this Agreement shall be venued in Circuite 8, Billings County, North Dakota.
